**NOTICE OF OBJECTION DEADLINE FOR THE DEBTOR'S APPLICATION FOR AN
ORDER AUTHORIZING THE EMPLOYMENT OF QUARLES & BRADY LLP**

On November 12, 2013, the Bishop of the Roman Catholic Church of the Diocese of Gallup (the “**Arizona Entity**” or “**Debtor**”) filed the “Debtor’s Application for an Order Authorizing the Employment of Quarles & Brady LLP as General Reorganization and Restructuring Counsel for the Debtor and debtor-in-possession” (the “**Application**”) in which the Arizona Entity requests Court approval of employment of Quarles & Brady LLP (“**Q&B**”) to provide legal services to Debtor and debtor-in-possession in the above-captioned Chapter 11 reorganization case (the “**Reorganization Case**”). Q&B has filed a verified disclosure pursuant to Bankruptcy Rules 2014 and 2016 (the “**Boswell Statement**”). The Application and Boswell Statement may be viewed for a per page fee via the PACER (Public Access to Electronic Court Records) system. Log on to PACER at ecf.nmb.uscourts.gov. For registration and use instructions, see pacer.psc.uscourts.gov/index.html. You may also view this document at no charge from a computer at the Office of the Clerk of the United States Bankruptcy Court between 8:30 a.m. and 4:30 p.m., Monday through Friday, at the Federal Building and United States Courthouse, 500 Gold Ave., S.W., Tenth Floor, Albuquerque, New Mexico 87102.

The Application requests authority for the Arizona Entity to employ Q&B, and to pay Q&B monthly, upon receipt of Q&B’s billing statements and prior to the Court’s allowance of Q&B’s fees and costs, 75% of billed fees, 100% of billed costs and 100% of gross receipts tax on fees and costs that the Arizona Entity is authorized to pay, to be paid from funds of the estate. If the Application is approved, the rate structure agreed upon for this matter will be as follows: Senior Partner: \$375 per hour; Junior Partner: \$300 per hour; Senior Associate: \$250 per hour; Junior Associate: \$200 per hour; and Paralegal: \$125 per hour. With respect to the rate of Susan G. Boswell, she will bill at the rate for a Senior Partner for the first 125 hours of her time spent on the Reorganization Case commencing on August 1, 2013. After Ms. Boswell has billed 125 hours to the Reorganization Case, Ms. Boswell’s hourly rate will increase to \$495 per hour throughout the remainder of the representation. Q&B will itemize costs; applicable gross receipts tax will be added to fees and costs; statements to the Arizona Entity will be rendered monthly. All amounts paid by the Arizona Entity to Q&B would be subject to ultimate approval of the Bankruptcy Court under Bankruptcy Code §§ 328, 330 and 331. The Arizona Entity requests that Q&B’s employment be made effective as of November 12, 2013.

Any party who objects to the Application must file its objection with the Clerk of the United States Bankruptcy Court for the District of New Mexico within 21 days after the date of

mailing of this notice, plus three days due to service of this Notice by mail, and serve a copy of the objection on Susan G. Boswell at the address given below. Objections must be filed electronically to the extent required by New Mexico Local Bankruptcy Rule 5005-4. The Clerk's address (for use if electronic filing is not required) is Clerk's Office, United States Bankruptcy Court, District of New Mexico, P.O. Box 546, Albuquerque, NM 87103-0546. If any objections are timely filed, a hearing will be held on notice only to Counsel for the Arizona Entity and objecting parties. If no objections are timely filed, an order granting the Application will be presented for entry without a hearing or further notice.
