NOTICE OF STATUS HEARING

NOTICE is hereby given that a status hearing (“**Status Hearing**”) will be held before the Honorable Judge David T. Thuma on **Monday, April 20, 2015 at 10:30 a.m. MDT** at the Dennis Chavez Federal Building and United States Courthouse, 13th Floor, Hearing Room 13102, 500 Gold Avenue S.W., Albuquerque, NM 87102, on the above-captioned, jointly-administered reorganization cases of the Roman Catholic Church of the Diocese of Gallup (“**RCCDG**”) and the Bishop of the Roman Catholic Church of the Diocese of Gallup (the “**Arizona Entity**,” and together with RCCDG, the “**Debtors**”).

At the Status Hearing, the Debtors will update the Court and parties on the status of:

- a. The reorganization cases generally;
- b. The investigation of insurance coverage for abuse claims, including:
 - (i) the Debtors’ responses to informal discovery requests submitted to the Debtors by the Official Committee of Unsecured Creditors (the

“**Committee**”), Catholic Mutual Relief Society (“**Catholic Mutual**”) and New Mexico Property and Casualty Insurance Guaranty Association (“**NMGF**”); and

- (ii) the investigation of additional insurance and claims against third parties.
- c. Real Property valuation and sales;
- d. Potential litigation, including indemnification and contribution claims against third parties and avoidance/declaratory relief actions regarding the Debtor’s title to property; and
- e. Plan mediation.

At the Status Hearing, the Debtors will request an Order directing necessary parties (including the Debtors, the Committee, insurers and other third parties who the Debtors or the Committee have identified as necessary to a consensual plan) to attend and participate in a mediation so that the Debtors can confirm a consensual plan. As part of such Order, the Debtors will request the Court set outside dates by which the mediation must commence.

Parties wishing to appear by telephone must call **CourtCall at (866) 582-6878** no later than 12:00 p.m. MDT on April 16, 2015. CourtCall will provide counsel with written confirmation of a telephonic appearance, and give counsel a number to call to make the telephonic appearance. It is counsel’s responsibility to dial into the call no later than 10 minutes prior to the scheduled hearing. CourtCall does not place a call to counsel. CourtCall charges a flat fee for the first 45 minutes you are connected. Telephonic appearances longer than 45 minutes will be charged for each additional 15 minute increment. timely call and connect with the CourtCall operator, you will be billed for the call and the hearing may proceed in your absence.
